Vehicles must be reported as a sales type "fleet" at the original time of sale. To become a U.S. Ford Fleet account, for vehicles that which are owned and operated in the United States, you must register for a U.S. Fleet Identification Number (FIN) Code. You will also be asked to provide proof of [eligibility](#) documentation for the vehicles in your fleet. This powertrain warranty extension will stay with the vehicle even if the vehicle is subsequently sold to a non-fleet customer before the expiration. This extension applies to both gas and diesel powertrains.
